### **PROPOSAL 1 UNITING THE REPUBLICAN PARTY** **COMMITTEE VOTE: PASSED 15-6-0**

**WHEREAS**, The Arizona Republican Party has alienated and eroded support of a number of its members, leading to losses in three successive elections;

**WHEREAS**, The Arizona Republican Party should return to being a "big tent" where leadership does not promote or demean any candidate in the primary elections; therefore be it

**RESOLVED**, That the term RiNO, which is meant to demean legitimate longtime Republicans, needs to be removed from the political lexicon of the Arizona Republican Party in order to create a more unified Party;

**RESOLVED**, Civic discourse must be restored.

### **PROPOSAL 2 HONORING JOHN MCCAIN** **COMMITTEE VOTE: FAILED 4-21-0**

**WHEREAS**, McCain is a Navy Aviator, and while doing so was shot down in Vietnam and remained there from 1967-1973 as a prisoner of war;

**WHEREAS**, John McCain was a member of the House of Representatives for four (4) years, a Senator in Congress for over 30 years, and the Republican nominee for President in 2008;

**WHEREAS**, John McCain received the Silver Star, Legion of Merit, and Presidential Medal of Freedom, awarded posthumously; therefore be it

**RESOLVED**, That the Arizona Republican Party remember and acknowledge John McCain as one of the most dedicated Arizona statesman and a lifelong Republican who embraced bipartisanship.

**RESOLVED**, that the AZGOP establish an official guide to include a formal protocol with corresponding policies and procedures providing step by step, how-to instructions for:

- a) identifying erroneous voter registration information,
- b) calling it to the attention of government officials responsible for the quality control and related maintenance of all applicable voter registration databases, and,
- c) ultimately confirming the removal of an erroneous voter record.

**WHEREAS**, the AZGOP affirms that our children – and all students alike – naturally thrive in an educational environment governed by school board members who, in good faith, honor the above in the administration of their official duties;

**WHEREAS**, the objective of school boards is to serve as advocates for students, establish a vision for school districts, provide structure and support, and ensure accountability;

**WHEREAS**, the 1776 Project is dedicated to electing school board members who are committed to positively reforming our public education system through the promotion of patriotism, humility, and pride in American history; and

**WHEREAS**, the 1776 Project is committed to abolishing Critical Race Theory (CRT) and The 1619 Project from the public school curriculum; now therefore be it

**RESOLVED**, that the AZGOP hereby invites The 1776 Project to help AZGOP organize, recruit, and promote Republican governing school board candidates in each and every school district throughout Arizona who are openly;

## **PROPOSAL 5 DECLARING DATABASE INDEPENDENCE** **COMMITTEE VOTE: PASSED (17-9-0)**

**WHEREAS**, the longstanding status quo voter registration database platform, GOP Data Center, and its corresponding smart app, Campaign Sidekick, provide voter registration data in a manner less than ideally accessible, useful, or helpful to the State Committeemen (SCs) of the Arizona Republican Party (AZGOP);

**WHEREAS**, this important data is essentially kept under the control of the Republican National Committee (RNC) and others, beyond the control of We The SCs, essentially making us subservient to the RNC and others, the exact opposite of what the balance of power between We The SCs and the RNC and others should and must be;

**WHEREAS**, in the spirit of the exercise of due diligence it is important for We The SCs to take real, genuine, and responsible ownership of the AZGOP, that we stand, of, by, and for ourselves and our fellow Republicans;

**WHEREAS**, it is likewise important for We The SCs to take ownership of our own respective precincts; and

**WHEREAS**, it is important for We The SCs to eliminate arbitrary, compulsory, and excessive dependence upon the RNC, GOP Data Center, Campaign Sidekick, and others, including unknown or untold database contractors, management systems, analytics, trackers, and other related infrastructure; now therefore be it

**RESOLVED**, that We The SCs hereby declare our voter registration database independence and call upon the AZGOP to establish and take ownership of its own voter registration database, establishing appropriate terms and conditions for the use thereof by SCs (and PCs), in compliance with all applicable laws.

**WHEREAS**, No court of law has ruled that the 2020 Presidential election was not legitimately won by Joe Biden, and no proof to the contrary has come forward; be it therefore

**RESOLVED**, That the Republican Party of Arizona will accept these results and not belabor or try to overturn old elections, but work to win upcoming ones.

## **PROPOSAL 8 CENSURE MARICOPA BOARD OF SUPERVISORS COMMITTEE VOTE: PASSED (22-1-3)**

**WHEREAS**, the Republican National Committee and the Republican Party of Arizona filed two lawsuits on October 4th, 2022 against Maricopa County, Arizona over policies favoring Democrat poll workers over Republicans.

**WHEREAS**, Maricopa County Recorder Stephen Richer was censured by the MCRC Executive Governance Committee on August 4th, 2022 and Legislative District 9 on October 26th, 2022.

**WHEREAS**, Maricopa County Board of Supervisors Chairman Bill Gates was censured by the Maricopa Legislative District 3 Republican Committee on August 11th, 2022. **WHEREAS** Maricopa County Supervisors Bill Gates, Clint Hickman, and Jack Sellers voted NOT to comply with the Arizona Senate audit of the 2020 Election.

**WHEREAS**, the 2022 General election in Maricopa County was fraught with avoidable errors, leading to significant voter disenfranchisement.

**WHEREAS**, the Arizona Senate Signature Audit report on October 2nd, 2022 revealed at least 1,298 ballots cast by dead voters and 17,822 mismatched ballots.

**THEREFORE, BE IT RESOLVED**, the Republican Party of Arizona hereby formally censures Maricopa County Recorder Stephen Richer, Maricopa County Supervisor Bill Gates, Maricopa County Supervisor Clint Hickman, and Maricopa County Supervisor Jack Sellers.

- 6) our right to medical privacy when asked for vaccine status to access services,
- 7) our right to operate a business without having additional extra legal government dictates determine the time, place and circumstances of how a property owner would conduct business, we stand

**WHEREAS**, the reliability, accuracy, and integrity of ballot printer and ballot tabulator machines  
at vote centers is in serious doubt;

**WHEREAS**, the ability of elections department employees and contractors to trace, identify,  
and audit jurisdiction-specific ballots cast at all-in-1 vote centers throughout a county is unknown;

**WHEREAS**, the validity of vote-by-mail ballots depends solely upon purported voter signatures  
never personally witnessed by individuals at the elections department performing signature verification;

**WHEREAS**, ballot drop boxes enable illegal ballot harvesting; now therefore be it

**RESOLVED**, that the Arizona Republican Party hereby supports:

- 1) returning to Election Day-only voting;
- 2) voting in-person on pre-printed ballots at a voter's election precinct polling place (except  
for qualified absentee voters – military, overseas, disabled, illness, certain occupations) with  
precincts averaging 1000 registered voters;
- 3) requiring in-person, state-approved Voter ID and in-person voter signature before a voter  
receives a ballot;
- 4) all ballots counted by hand under camera AND verified by non-internet tabulating equipment  
under appropriate supervision at individual polling places; and
- 5) eliminating all ballot drop boxes including USPS mailboxes.
- 6) incorporating a unique watermark on ballot paper used.

## **PROPOSAL 14 PC TRANSFERS** **COMMITTEE VOTE: PASSED (21-5-0)**

**WHEREAS**, A precinct committeeman (PC) may relocate residence to another precinct or legislative district within the same county; and,

**WHEREAS**, Current Arizona law (A.R.S. Title 16) and current MCRC bylaws require a PC to resign when moving out of a precinct; and,

**WHEREAS**, Precinct committeemen are the backbone of the Republican Party; and,

**WHEREAS**, Recruitment, training and retention of committed precinct committeemen is vital to the strength of the Republican Party; therefore, be it

**RESOLVED**, That the Republican Party of Arizona will support state legislative change, and urge county committees, and legislative district committees, to adopt similar resolutions and bylaw changes to allow PCs to transfer elected status, without resignation, to another precinct or legislative district, under the following conditions:

- 1) The precinct committeeman's new precinct is within the same county; and,
- 2) The precinct committeeman's new precinct has a vacancy; and,
- 3) The Precinct Captain of the receiving precinct approves; and,
- 4) The Chair of the receiving legislative district approves; and,
- 5) The precinct committeeman, within 30 days after moving to the new precinct, properly updates voter registration status and obtains ten nomination signatures from registered Republicans residing in the precinct committeeman's new precinct.

## **PROPOSAL 15 DEMANDING A NEW ELECTION COMMITTEE VOTE: PASSED (20-6-0)**

IN WITNESS WHEREOF, We the Precinct Committeemen (PCs) of the Arizona Republican Party stand united in support of calling on all state legislators to join us in demanding a new election in protest of what is clearly a potential fraudulent election.

**WHEREAS:**

- 1) Maricopa County reported at least 70 different vote centers experienced problems with the Ballot-On-Demand printers and tabulators on election day, November 8, 2022.
- 2) Election officials reported 17,000 Election Day ballots were placed in ballot box "Door 3" for provisional or unreadable ballots.
- 3) Many of us who worked and observed the vote centers on election Day witnessed a variety of problems, ranging from printer and tabulator errors, lack of paper, lack of toner or ink at a multitude of vote center polling sites, leading to an abundance of ballots being spoiled.
- 4) The above errors-and more-were directly responsible for excessively long lines, conflicting statements by election officials both inside and outside vote centers, and resulted in mass confusion and anxiety for voters simply trying to exercise their basic right to vote.
- 5) Although election officials may represent every lawful and legal vote will be counted, how are we to know this, how are we to confirm this, and how are we to audit this with the serious breaches of chain of custody that were committed?

## **PROPOSAL 16 AMENDED - DESPICABLE BEHAVIOUR AND GAMESMANSHIP COMMITTEE VOTE: PASSED (26-0-0)**

**WHEREAS**, as a body, we find it despicable that some in our party have gone as far as trying to set up fellow Republicans for assault and battery charges, and on video for social media attacks, in an effort to get an upper hand in intra party elections; be it

**RESOLVED** that we as a Republican Party do not uphold this type of behavior or bullying among our members.

## **PROPOSAL 17 DISCLOSE BILLIONAIRE DARK MONEY COMMITTEE VOTE: PASSED (20-4-2)**

Under the new dark money disclosure law passed in Nov. anyone who spends more than \$5,000 in ads must disclose the donors name & home address in original source of funding, but 3 giant loopholes were created.

Dark money disclosures not required from 1) Fake nonpartisan groups receiving over \$100 million in dark money from Facebook and Soros are not required to disclose funding and 2) News media sources like Daily Courier run by democrat operatives are not required to disclose funding sources and 3) Labor unions disclosures are not required.

Money = free speech under the 1<sup>st</sup> amendment and Citizen United, and disclosure of a person's name and home address goes too far under Prop 211. Donors have the right to personal privacy, and their corporate name and corporate address is sufficient to understand the source of the money.

NOW Therefore, the AZ Republican party leaders requests, legislators prepare a HCR ballot measure to require funding disclosure by liberal organizations receiving millions from Zuckerberg & Soros as part of the Prop 211 Dark money disclosure law.

If disclosure is required of conservative groups giving money for elections, liberal groups should also disclose.

- 2) voting in-person on pre-printed ballots at a voter’s election precinct polling place (except for qualified absentee voters – military, overseas, disabled, illness, certain occupations) with precincts averaging 1000 registered voters;
- 3) requiring in-person, state-approved Voter ID and in-person voter signature before a voter

**WHEREAS**, 300,000 ballots cast in the 2022 Midterm Election lacked the requisite chain of custody and tens of thousands of mail-in ballots and drop box ballots were allowed without proper signature verification;

**WHEREAS**, officials' misconduct and/or malfeasance caused thousands to be disenfranchised by tabulation and/or printing machine failures in 59% of 223 voting centers in Maricopa County in November 2022;

**WHEREAS**, ARIZONA's "legitimate state interest" in preventing election fraud is affirmed in *Brnovich v. Democratic National Committee*;

**WHEREAS**, Arizona legislators' hearing November 30, 2020 revealed expert testimony and documentation of Arizona's voting machine vulnerabilities to illegal ballots cast surpassing the margin of victory;

**WHEREAS**, Arizona Senate's forensic audit of Maricopa County's subpoenaed 2020 election records exposed 49,718 questionable votes.

**WHEREAS**, Maricopa County officials admitted deleting election data routed onto archive files omitted from subpoenaed 2020 election records;

**RESOLVED**, that Arizona Republicans demand Arizona laws:

- 1) RESTORE Election Integrity and Confidence to guarantee Arizonans have one vote per election per citizen.
- 2) REQUIRE valid identification and proof of citizenship for all ballots.
- 3) FACILITATE prevention of illegal ballot harvesting.
- 4) AUDIT and purge permanent early voter list of voters who haven't voted in two previous election cycles.
- 5) PROHIBIT connecting ballot counting devices to the internet.
- 6) PROHIBIT software updates after bipartisan certification.
- 7) IMPLEMENT safeguards for retaining and securing accurate election records.
