

#### OFFICIAL CALL LETTER: MANDATORY MEETING

Fellow Patriot and State Committeeman,

You are hereby notified that the Mandatory Meeting of the state committee of the Arizona Republican Party will be held on Saturday, January 27, 2024, at Dream City Church located at 13613 N. Cave Creek Road, Phoenix, Arizona 85022. You can access the parking for the Church by entering on North 22nd Street from Sweetwater Avenue or Eugie Terrace from Cave Creek Road.

The meeting is called for the purpose of electing such officers as required by law and the bylaws of the Party, and for conducting other business as may come before the body. Registration will be conducted beginning at 8:00 AM for the Maricopa County Republican Committee and its corresponding Legislative Districts, and 8:30 AM for all other County Committees. Credentialing will end at 10:00 AM with the meeting convening promptly at 10:00 AM. We are pleased to be joined by the Gila County Elections Office to administer all ballot elections.

At all meetings of the State Committee, members are entitled to vote in person or by proxy given to a qualified Republican elector of the same county and congressional district (or in the case of counties with 500,000 or more population, and legislative district) where the member resides. Members shall carry no more than three (3) proxies. Every proxy must be attested by a Notary Public or two witnesses, other than the principals, brought to the meeting by the carrier, and it shall be in full force and effect only for the length of the meeting.

State Committeemen attending by proxy may be called during credentialing to verify witness signatures. You will find a copy of the proxy form enclosed. The form shall be filled out in its entirety, completely and accurately, with no blank fields or scratch-outs. State committeemen or their designated proxies are required to present photo identification in order to conduct business, receive ballots, and cast votes. As a reminder, credentials are not transferable at any time during the course of the meeting.

Enclosed in this call letter are the chairman's letter, agenda, map of venue, rules, proposed bylaws changes, proposed resolutions and nominating committee report. Additional nominations and resolutions may be brought forward from the floor per the meeting rules and requirements in the bylaws. You may visit AZGOP.com/mandatory at any time to view this letter, the full body of the resolutions and bylaws as well as the minutes from the 2023 Statutory Meeting. #### **CHAIRMAN'S LETTER**

Dear State Committeemen of the Arizona Republican Party,

It is my distinct honor to welcome you to the 2024 Mandatory Meeting of the AZGOP. This year's theme is Unity. With so much at risk, NOW is the time to pull together to win the upcoming elections. We must unify and beat the Democrats while we still have time to save Arizona and America from the woke left and their policies of high taxes, open borders, socialism, and so much more that would ruin our great country.

I am a lifelong Constitutional Conservative, longtime PC and donor to Republican candidates, and defender of the values we hold dear. I was honored to have earned your vote to be the State Treasurer of Arizona in 2014, winning Statewide in a year where we took all six Statewide offices, both Senate seats were red, and we had overwhelming majorities in our state house and state senate, which was the last year such a feat was accomplished. I know what it takes to do it again, and we are building the organization that can do it again.

During my time fighting for hardworking taxpayers, I was proud of the headlines that came from my office, such as "All-time records reached for Arizona Endowment Fund" (8/3/2017) and "Arizona endowment investments managed by State Treasurer's office outperformed most endowments and pension funds in the United States and outperformed all of Arizona's public pension funds during the same time period" (12/8/2016). As I used to say, the better your State Treasurer does, the less Arizona needs of your taxes.

President Donald Trump trusted me with helping him get elected in 2016 by making me the Chief Operating Officer and Chief Financial Officer of the entire Trump campaign, and we beat the Clinton machine with less than half the money and 1/8<sup>th</sup> the staff. I gained invaluable knowledge about how to operate every aspect of a campaign, which is why President Trump brought me back in 2020 as the COO of his campaign once again after spending two years serving in his Administration in DC as the CFO of NASA. As one of the few people in Arizona who have won both statewide and nationally, I know what to do in 2024 to win here once again.

The AZGOP has had many successes so far this year:

- Raised more money in the off year before a Presidential election cycle than any State Party Chairman in Arizona history.
- Intervened in a lawsuit and kept President Donald J. Trump on the ballot in Arizona.

- Developed the AZGOP app, a first ever branded app for the party, available in the iPhone App Store and Google Play store, to provide easy access for activists to reach out to voters via walking door to door, calling, texting, sending postcards, etc.
- Stopped Adrian Fontes from misusing the Secretary of State's Office to force unqualified political parties onto the ballot at the disadvantage of Republican candidates.
- Succeeded in Upholding the Integrity of the Petition Signing Process and kept Patriot Party off the ballot.
- Launched the AZGOP Elephant Club, a new fundraising effort that allows donors to provide sustaining monthly donations dedicated to winning elections in Arizona.
- Launched the vastly updated AZGOP PC Handbook: A detailed resource packed with knowledge and strategies to empower PCs, offering more than just guidance.



- Enhanced communication across Legislative Districts, regularly sharing positive updates (send an email to <u>comms@azgop.com</u> and say "Add me" if you are not receiving these).
- Engaged with Native American and Latino communities throughout Arizona, coordinating messaging strategies that align with conservative values.
- Conducted extensive training sessions for candidates, PCs, LD Chairs, Members-at-Large, and county chairs.
- Organized voter registration drives at numerous events statewide.
- Overhauled the email fundraising, website, and much more!

Throughout the state, our county parties and LDs have demonstrated incredible effort and achieved significant successes. Among these, the defeat of school bonds in multiple districts stands out, showcasing unity, diligent work, and strategic acumen. The concerted ballot chasing campaign resulted in substantial victories for Republicans across Arizona. Additionally, many districts have witnessed a significant increase in PC recruitment, a clear testament to the prevailing sentiment among Arizonans and their readiness to work hard to turn Arizona red again. This is the kind of success we strive for – winning together.

We are recruiting good conservative candidates, raising money, and building a top-notch get out the vote machine. We are on track to raise more money, by far, than ever in the history of the AZGOP. We are about to give money to every LD and every county party, which will be the first time the state party has done such. And we are working hard to give all our PCs the tools and resources they need to help all of our Republican candidates get over the finish line in the general election.

The Republican Party is a ground-up, grassroots organization. Republicans elect Precinct Committeemen, Precinct Committeemen elect State Committeemen, State Committeemen elect State Chairman, and State Chairmen are voting members of the Republican National Committee whom elect the National Chairman. #### **MAP OF VENUE**

All State Committeemen and ADA should access GENERAL PARKING and ADA PARKING from North 22nd Street from Sweetwater Avenue or Eugie Terrace from Cave Creek Road. Please report to the MAIN HALL LOBBY for Credentialing. Credentialing for Maricopa County will begin at 8:00 AM and for all other counties at 8:30 AM.

The MAIN HALL is where the Mandatory Meeting will begin promptly at 10:00 AM.

Speakers and media should access the SPEAKER and MEDIA PARKING LOT to the north on Sharon Drive from Cave Creek Road. There will be a Media registration table outside of the Main Hall. Media shall remain outside and not be allowed inside the lobby or the Main Hall.

ALL State Committeemen (including Speakers) should proceed directly to their County/LD credentialing table.

State Committeemen can request to sponsor a guest by filling out the Guest Sponsorship Form at azgop.com/mandatory. The deadline to submit a request to sponsor a guest is January 22, 2024, at 11:59PM. No requests will be accepted after the deadline. The AZGOP Guest Committee will inform the sponsor of their decision at least 48 hours prior to the Mandatory Meeting.





#### **MEETING RULES**

RULE 1 SUPREMACY CLAUSE These rules shall govern the mandatory meeting of the State Committee of the Arizona Republican Party in all cases to which they are applicable and in which they are not inconsistent with the laws of the United States, the State of Arizona, and with the continuing Bylaws of the Arizona Republican Party. All matters not otherwise covered herein shall be governed by the latest edition of Robert's Rules of Order, Newly Revised.

RULE 2 QUORUM Thirty-three percent (33%) of the total membership of the State Committee as well as representatives from at least eight counties shall be present, either in person or by proxy, in order to constitute a quorum for the purpose of conducting such business as was listed in the meeting call.

RULE 3 OFFICERS AND THEIR DUTIES The officers and their respective duties shall be as follows A. The present State Chairman, or designee, shall preside at all times during this meeting. The State Chairman shall appoint all committees and members thereof. B. The Secretary of the State Committee shall be the secretary of the meeting and shall prepare the minutes. C. The current elective officers and appointive officers of the State Committee shall serve in their respective positions until new officers are sworn into office. The State Chairman is empowered to appoint a parliamentarian. Decisions of the parliamentarian on matters related to the Rules shall be final and unappealable.

RULE 4 ORDER OF BUSINESS The Order of Business shall be the order prescribed in Article III, Section G, Subsection 3 of the State Party Bylaws provided that the Chairman is authorized to use discretion to deviate from the order to present introductions, speeches and other matters, as time may permit.

RULE 5 DEBATE AND SPEECHES Except for speeches which are scheduled on the program of the day, the following limitations apply to debate and speeches during the meeting. A. NOMINATION SPEECHES -Nominating and seconding speeches, and speeches by the candidates, will be allowed for each candidate with a maximum total time limit of 3 minutes. Each candidate is to allocate the time according to their own desires. Candidates delivering nominating and seconding speeches shall have access to the floor for the purpose of making those speeches as permitted by the State Chairman. Candidate speeches shall be conducted alphabetically by candidate last name for each office. B. METHOD OF AMENDING BYLAWS - An amendment to the bylaws may only be proposed at the mandatory meeting if a copy of the proposed amendment, together with a statement explaining the purpose to be achieved and the reasons in support thereof, have been mailed to each member by the secretary with the notice of call. A two-thirds vote of the members present in person or by proxy shall be necessary to pass any motion to amend. C. DEBATE ON BYLAWS CHANGES - Debate on all bylaws changes shall be limited to a maximum of 6 minutes per bylaw change. The time shall be evenly divided between proponents and opponents of each bylaw change. D. ADDITIONAL BYLAW AMENDMENTS - Amendments to the bylaws from the floor will not be permitted at the mandatory meeting. E. DEBATE ON RESOLUTIONS - Debate on all resolutions shall be limited to a maximum of 4 minutes per resolution, including subsidiary motions to each resolution. The time shall be evenly divided between proponents and opponents of each resolution. F. LIMITATIONS ON SPEAKERS -No person may speak on any one resolution or bylaw proposal longer than a total of 1 minute. No person may speak a second time on any one resolution or bylaw proposal until other people have had an opportunity to speak upon such issue, with the exception that the author of the proposed resolution or bylaw being debated may be called upon to answer questions directed to them specifically, provided that such speaker shall take no longer than one minute to answer each such question. No person may speak more than three times on three separate resolution or bylaw proposals, with the exception that the author of the proposed resolution or bylaw



proposal may always speak on that proposal if called upon. Only credentialed State Committee members may be recognized to speak.

RULE 6 COMMITTEES A. CREDENTIALS COMMITTEE - The Credentials Committee shall have the responsibility for registering all qualified members entitled to vote or participate in the meetings of the State Committee. Registration shall close at 10:00 a.m. after which the Credentials Committee will promptly submit its report to the State Chairman for appropriate action. After the initial Credentials Committee report has been accepted, the State Chairman may reopen registration and the Credentials Committee may thereafter submit supplemental credentials reports to the State Chairman for appropriate action. Once credentials are issued, no transfer of credentials is permitted. No new registrations may be added while a vote on a nomination, resolution or bylaw change is in progress. In Maricopa and Pima counties, the Credentials Committee shall register the members in the legislative districts from which they were elected. Spoiled ballots must be taken to the Spoiled Ballot table and be logged in by Credentials/Tally Staff in order to receive a replacement ballot. State Committeemen leaving the meeting prior to the completion of all rounds of voting are required to sign out and drop off unused ballots and credentials at the check-out desk. B. NOMINATING COMMITTEE -Prior to the commencement of the meeting, the Nominating Committee will review the qualifications of all candidates for all offices submitted and shall report to the State Committee the names of all nominated candidates qualified for each mandatory office. All nominated candidates must be State Committeemen at the time of their election. C. RESOLUTIONS COMMITTEE - The Resolutions committee will review the submitted resolutions and submit the resolutions committee report to the Chairman in accordance with the bylaws. At the discretion of the Chairman, resolutions approved by the Resolutions Committee may be adopted pursuant to a single block vote. 1. Resolutions Offered from the Floor. A resolution may be offered from the floor subject to the following: (a) A resolution to be offered from the floor must be accompanied by a written list of co-sponsors that shall total at least 20% of the state committeemen present in person and who represent at least four counties. Persons present by proxy do not count for the purpose of the preceding 20% requirement. (b) The sponsor of a resolution to be offered from the floor shall provide sufficient copies so that the proposed resolution may be distributed to all state committeemen present in person. (c) The sponsor of a resolution to be offered from the floor shall present a copy of the proposed resolution, together with the list of cosponsors, to the Chairman of the Resolutions Committee, no later than 9:00 a.m. on the day of the meeting. If a proposed resolution to be offered from the floor is received by the Resolutions Committee in a timely manner, it shall promptly meet to verify that the proposed resolution meets the criteria for floor resolutions. A list of all resolutions to be offered from the floor, that are verified as having met the criteria established by these Rules, shall be delivered to the Chairman immediately following the conclusion of the review by the Resolutions Committee. It shall only be in order to offer a resolution from the floor as the next order of business immediately following action by the State Committee on any resolutions offered by the Resolutions Committee. Notwithstanding any other rule, no resolution may be presented from the floor other than in compliance with this Rule. At the time a sponsor of a resolution to be offered from the floor is recognized for the purpose of offering the motion a copy of the proposed floor resolution shall be distributed to each State Committeeman present. 2. Additional Considerations. No amendments or changes to a resolution will be heard from the floor or considered in order at any time. D. COMMITTEE REPORTS - The final report of all committees shall be submitted in writing to the Secretary of the State Committee and shall be signed by the Chairman or Secretary of the committee.

RULE 7 NOMINATIONS The names of those persons contained in the report of the Nominating Committee shall be considered as nominated for the respective position for which the name is submitted. Nominations may be made from the floor for all offices, subject to verification of a nominee's qualifications to hold such office.



RULE 8 VOTING A. All votes on non-contested elections and on all other matters shall be by voice vote. In the event the chair is in doubt as to the outcome of a voice vote the chair shall call for a show of hands. B. All votes on each contested officer election shall be cast by paper ballot. The winner of a contested election shall be the person receiving a majority (50%+1) of the votes cast for that office by persons present and voting or present and voting by proxy. C. The chair of the Tally Committee or their designee shall oversee the electronic tabulation of ballots. When the tabulation of ballots is complete the Tally Committee chair or their designee shall deliver the results to the State Chairman. The State Committee Chairman shall then promptly announce the balloting results to the State Committee. D. In the event no individual shall receive a majority of the votes cast on the initial round of balloting, a second round of balloting shall take place. In the event no individual receives a majority of votes cast following the second round of balloting, additional rounds of balloting shall occur until one person receives a majority of the votes cast. However, beginning with the second round of voting, half of individuals receiving the lowest number of votes in the preceding round of balloting shall no longer appear on the ballot. In cases where an uneven number of candidates appear on the ballot, 50% plus one will remain on the ballot. (i.e., if there are five candidates in the previous round, then three would remain on the ballot for round 2.) In the case of a tie for continuation for next round, both candidates who received the same amount of votes shall be included on the ballot for the next round. F. Each candidate for Party office may designate one individual to observe the tabulation of ballots. G. Votes cast for candidates nominated from the floor shall consist of the following: 1.) A clear and complete mark in the corresponding oval. 2.) At least the last name of the candidate written on the corresponding line in a legible manner that clearly indicates voter intent.

Republican Party Bylaws Section F. B. The Auditable Trail shall consist of the Credentials Report and supporting documentation, Cast Vote Record, Canvass Report from the Election Management System (EMS) produced by the vendor's equipment inclusive of any potential Hand Count Report, Tally Report, and summary of total ballots cast/spoiled/distributed. Documents within the Auditable Trail shall be subject to the same retention policy as prescribed in the Arizona Republican Party Bylaws Section F.

**RULE 10** AMENDMENTS Once adopted, these rules may be subsequently amended by a two-thirds vote of those present in person.
